Dear Friend.

On April 1, 2005, full time firefighter crews at the Wagstaff Circle Fire Department, 2101 Adkins Road, will temporarily re-locate to the Manchester Volunteer Rescue Squad building, 3500 Courthouse Road. This move is due to a mold problem that has been determined to be a health and safety issue to those that live in the building. Firefighters will continue to respond to emergency calls in the area and the response time goals of the department will continue to be met.

Volunteer firefighters will continue to respond apparatus out of the station on Adkins Road, but these volunteers will not be staffing the station on a 24-hour a day basis. Citizens should be aware that if they stop at the Wagstaff station for assistance, there might not be anyone in the station to assist them.

This will not cause a change in how citizens will call for fire or emergency medical services assistance. Dialing 9-1-1 will still allow our Emergency Communications Center to dispatch the appropriate units to the scene.
