Neighborhood Watch

Steve Forbes reports that calls to the Loch Braemar neighborhood by Chesterfield County Police are few. However, Chesterfield Police report over 50 robberies in the last quarter in Chesterfield County primarily due to unlocked homes. Usually, the house is locked and the garage/shed doors are shut *but not locked*. Often, the interior door from the garage is unlocked as well, making entry into the home very easy. Remember to lock <u>all</u> your doors when you leave, and keep an eye on your neighbor's homes as well.

The Board has had calls complaining about 16-20 year olds ringing door bells in our neighborhood and asking for cigarettes. If you notice a suspicious activity, please report it to the Chesterfield County Police Department right away, so the situation will be resolved.

Door-to-door solicitation originating from outside the neighborhood continues to be a problem. The Board is considering posting a "No Solicitation" sign at the front entrance to help discourage solicitors.
